## 4.0 NEW BUSINESS

4.1 Human Trafficking Webinar Series – Supporting Students and Schools Through A Human Trafficking Report

The Committee received information on a conference via Zoom, which was being held on Wednesday, January 31, 2024, regarding human trafficking in America's Schools. Members were encouraged to attend.

4.2 Parenting and Paternity Awareness (P.A.P.A.) Training

The Committee viewed a short video on Parenting and Paternity Awareness (P.A.P.A.). Amber Mathews noted that there is a training being held today (January 31, 2024) at Region 7 and we were able to send a CHS teacher to learn more about this. The 80<sup>th</sup> Legislature passed HB 2176, which mandates a parenting and paternity awareness program to be utilized in the high school health curriculum beginning in the 2008-2009 school year. The program is required when health is taught at the high school level. Amber Mathews will provide more information at the next meeting on how this program will be utilized at CHS.

4.3 Monthly Goodside Report

Lindsey Montario provided the Committee with information related to the monthly Goodside visits. There were 156 total sick visits, \$9,743 average daily attendance dollars saved, 1,393 academic hours saved and 22% of the students/staff returned to the classroom. Members discussed the availability of the nurse at CMS.

4.4 Ross Breast Center Mammogram Bus Schedule

Joyce Permenter announced the mammogram bus is scheduled on Tuesday, March 5<sup>th</sup> at FLM, March 12<sup>th</sup> at CMS, and March 19<sup>th</sup> at CHS.
